Disaster preparedness emergency kit program. Through implementing grantee Handicap International Federation (France), the organization carried out its disaster preparedness emergency kit program. This program creates and stocks emergency kits which are located near disaster-prone countries to be readily available in event of disaster or conflict. This program was made possible because the organization was the grateful recipient of the \$1.5 million 2011 Conrad N. Hilton Humanitarian prize.

Program Development

Program Impact Enhancement - Research and development of new partnerships, innovations and opportunities to enhance implementing grantee's program effectiveness and impact on the lives of beneficiaries in developing nations. Creation of tools and training to be used and given in the developing country context to enhance the quality and effectiveness of work and stewardship of donor funds in achieving our organizational mission.

Senegal - Mine Clearance

Implementing grantee Handicap International Federation worked to remove the danger of landmines and unexploded ordnance for affected communities in the Casamance Region. Surveys and full clearance were completed in three villages with a total of 8,725 square miles of confirmed hazardous areas handed over to the Senegalese Mine Action Authority. Handicap International Federation was also able to identify, mark and secure nine anti-personnel mines and five unexploded ordnance. In addition, 32 demined sites within eight villages were officially handed over to local populations, enabling the safe return of internally displaced persons (IDPs), and contributing to the restoration of peace, reconciliation, and stability in the communities.

The organization responded to the Sindh Province after the August-September 2011 floods. The emergency team produced 105 gallons of drinking water a day for 100,000 people. In addition to water treatment, the implementing grantee launched pumping operations to restore access to public buildings. A total of 2,500 packs containing blankets, mosquito nets, soap and emergency shelters were distributed to prevent the spread of epidemics. Education programs occur at local schools and health facilities, including the Kasese District Union of Persons with Disabilities. Victim support programs also occur in partnership with the Ugandan National Demining Centre.

Democratic Republic of the Congo

Provided funds to implementing grantee Handicap International Federation to procure and deliver explosives for training, demining and unexploded ordnance clearance operations in the Oriental Province. Handicap International Federation prepared training curricula for the United States Africa Command on humanitarian demining concepts, standard operating procedures, Victim Assistance, Data Collection, Mine Risk Education United Nations Mine Action Coordination Centre (UNMACC) procedures. UNMACC capacities in supporting the Congolese Army Mine Action activities were also enhanced by creating a more accurate database and increasing equipment availability.

Libya

Since launching operations in Libya in March 2011, the implementing grantee, the

Handicap International Federation, has destroyed more than 3,500 explosive remnants of war and reached about 50,000 people with mine risk education programs. School risk-education sessions have been enhanced through distribution of 20,000 children's textbooks.

DR Congo

The Handicap International Federation, implementing grantee, has worked in the Democratic Republic of Congo since 1995. Activities include long-term development work, as well as providing emergency humanitarian aid to refugees and displaced people in the east of the country which has been beset by violence. Handicap International is also working with Persons with disabilities that have been affected by the conflict in North Kivu, as well as participating in demining activities with the Education United Nations Mine Action Coordination Centre.

Cambodia

Since the Handicap International Federation (implementing grantee) was born out of the Cambodian refugee camps in Thailand, programs tend to involve both the Thai and Cambodian populations. In both countries the grantee works on mine action, mine risk education and rehabilitation projects. In a recent program, 298 persons received 396 prosthetic, assistive devices or repair services in three Thai border camps.

Handicap International Federation has also done trainings for refugee camp staff on various health issues, such as increasing the health of pregnant women to avoid birth defects.

Laos

The Handicap International Federation (implementing grantee) has worked to destruct 80 million unexploded cluster bombs and to mitigate the impact of war explosives on civilians through mine risk education. Other programs have included awareness rising on preventing road traffic accidents and working with Local Disabled Person's Organizations on disability rights issues.

Kenya

The implementing grantee, Handicap International Federation, works in Kenya and Somaliland in the areas of HIV/AIDS prevention, education, social inclusion, mine action and refugee support. In Kenya, Handicap International Federation has been working in Dadaab, the world's largest refugee camp with other 400,000 people. The organization, which has been working in northern Kenya for nearly 20 years, is mobilizing its resources to help thousands of persons with disabilities and vulnerable people survive in this particularly difficult situation. The teams provide emergency physiotherapy care and supply mobility aids, advice and essential psychological support.

Thailand

Provided funds to implementing grantee Handicap International Federation to build a sustainable network and mainstream resources for persons with disabilities by means of specialized and support services, empowerment processes and optimization of access. Preventive camp health care services were broadened and made disability inclusive by training over 200 staff on healthy pregnancies and general knowledge, skills and attitudes in identifying and referring people with disabilities for

rehabilitation. Nearly 500 people received appropriate physical rehabilitation and follow up care, with 257 people receiving over 400 new or repaired prosthetics and other assistive devices. Handicap International Federation also worked to strengthen the Disability Resource and Information Centers and posted three mass awareness events during the 2011 International Day of Persons with Disabilities. Work has also been done to reduce physical and social barriers to enable inclusion of people with disabilities in mainstream stakeholder services, such as providing training on disability orientation, and Universal Accessibility Design.

Haiti

In Haiti, the implementing grantee, Handicap International Federation, has piloted a program to limit the impact of the cholera epidemic on at-risk populations. Team members made daily visits to communities in Petit-Goâve and isolated villages (particularly in the mountains) to teach people simple hygiene practices that will help protect them from cholera. The organization has also widely distributed recommendations for including people with disabilities in the management of the response to the cholera epidemic, particularly regarding operators working in the fields of health, protection and camp management. In addition, more than 1,000 transitional shelters have been built with the intention to house 4,799 of the most vulnerable people who lost their homes in the 2010 earthquake. Many of these shelters have been equipped with wheelchair ramps to facilitate access for people with disabilities.

All staff and board members are made aware of the conflict of interest policy and their responsibility to report any potential conflicts of interest. Staff review and sign the policies and personnel manual at the time of their hire, which includes the conflict of interest policy. Senior staff review any situations that arise that might constitute a conflict of interest. Additionally at a scheduled meeting of the Board of Directors all directors are asked to review HI's definition of conflict from the organization's bylaws and to then affirm that they have done so and sign a new conflict of interest statement. No conflicts have arisen in 2011.
